SUMMONS FOR DIRECTIONS

LET ALL PARTIES CONCERNED attend before a Judge in Chambers, at the Law Courts, George Town, Grand Cayman on _____ 2026 at _____ am/pm for a hearing of an application by Maso Capital Investments Limited, Blackwell Partners LLC – Series A and Star V Partners LLC (together, the “**Petitioners**”) for the following orders:

1. There be no requirement for the petition filed herein (the "**Petition**") to be advertised in the Cayman Islands or elsewhere.
2. In the event that Sohu.com Limited (the "**Company**") seeks to defend the Petition, the matter is to proceed on the following timetable:
 - (a) The Petitioners shall not be required to file or serve further particulars of their claim;
 - (b) The Company shall serve written notice of its intention to defend within 14 days from the date of this Order and shall file any defence within 28 days from the date of this Order (the "**Defence**");
 - (c) If so advised, the Petitioners shall file a reply within 21 days of service of the Defence;
 - (d) The Petitioners and the Company shall exchange lists of documents within 56 days of the expiry of time for service of the Petitioner's reply under 2(c) above;

THIS **SUMMONS FOR DIRECTIONS** is filed by Campbells LLP, Attorneys for the Petitioner, whose address for service is Floor 4, Willow House, Cricket Square, Grand Cayman KY1-9010 (Ref: SRF/SDA/16351-41376)

- (e) Inspection shall take place within 14 days of the exchange of lists of documents;
 - (f) Evidence is to be given by affidavit and the deponents shall attend for cross examination at the hearing of the Petition if notice to do so is given by the party upon whom the affidavit is served within 21 days of service of the affidavit;
 - (g) Affidavits are to be exchanged within 42 days after inspection under 2(e) above; and
 - (h) The Petition be listed for a hearing on the first available date thereafter with a time estimate of two days.
3. In the event that the Company does not seek to defend the Petition, the Petition shall be listed to be heard at the next available date convenient to the Petitioner without the need for advertisement.
4. Liberty to apply.
5. The costs of and incidental to this Summons be reserved.
6. Such further or other order as this Honourable Court sees fit.
