THIS PLAINT has been issued against you by the above-named Plaintiff in respect of the claim set out on the following pages.

Within 14 days after service of this Plaint on you, counting the day of service, you must either satisfy the claim or return to the Court Office, PO Box 495GT, George Town, Grand Cayman, the accompanying Acknowledgment of Service form stating whether you intend to contest this action. If you intend to defend the action, in whole or in part, you must set out full particulars of your defence in the space provided in the Acknowledgment of Service form.

If you fail to satisfy the claim or fail to return the Acknowledgment of Service form containing full particulars of your defence, the Plaintiff may apply for a default judgment without any further notice to you.

PARTICULARS OF CLAIM

1. The Plaintiff is a company incorporated in the Cayman Islands which trades as Cayman Tennis Academy and carries on the business of providing tennis coaching and related services in Grand Cayman, Cayman Islands.
2. The Defendant is an individual who, at all material times was resident in the Cayman Islands.
3. In or about May 2025, the Defendant requested, and the Plaintiff agreed, that the Plaintiff would provide tennis lessons to the Defendant from time to time at the agreed rates set out in the Schedule below (the "**Agreement**").
4. The Agreement was made expressly and/or is to be implied from the Defendant's booking, attendance at and acceptance of the lessons and the parties' course of dealing.
5. Pursuant to the Agreement, between 31 May 2025 and 1 February 2026 the Plaintiff supplied the Defendant with 30 tennis lessons comprising 28 lessons of 1.5 hours and two lessons of one hour.
6. The dates, duration, rates and charges for those lessons are particularised in the Schedule below.
7. The total charges for the lessons supplied were CI\$4,220.00.
8. In September 2025, the Defendant made a part-payment of CI\$540.00. After credit for that payment, CI\$3,680.00 remains due and owing.
9. The Plaintiff issued invoices and/or statements of account and repeatedly sought payment by email between 29 September 2025 and 15 May 2026. The Defendant made no further payment.
10. By demand letter dated 14 July 2026, KSG Attorneys, acting for the Plaintiff, demanded payment of CI\$3,680.00 within 14 days. That period expired on 28 July 2026. The Defendant has failed and/or refused to pay.
11. The Defendant is accordingly in breach of the Agreement, and the outstanding debt of CI\$3,680.00 is immediately due and payable to the Plaintiff.

12. Alternatively, if there was no express agreement as to price, the sum of CI\$4,220.00 was a reasonable charge for the services requested and accepted by the Defendant, and the Plaintiff is entitled to the unpaid balance of CI\$3,680.00 as reasonable remuneration for those services.

4. Such further or other relief as the Court considers just.
