**PLAINT** has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

PARTICULARS OF CLAIM

---

1. The Plaintiff and the Defendant entered a relationship between April 2024 and July 2025. During this period, the Plaintiff assisted the Defendant with multiple financial obligations ranging from personal expenses to medical expenses.
2. True copies of the documents to which the Plaintiff shall refer in this Plaint are marked '**Exhibit-AK1**'.
3. Between the period of December 2024 and May 2025, the Plaintiff loaned funds to the Defendant totaling KYD\$14,660.00. These funds were used by the Defendant to pay for multiple expenses ranging from rental payment, utility bills, medical expenses, travel expenses and miscellaneous expenses. The parties agreed that repayment would be sourced from the proceeds of a property sale and/or a Government payout to the Defendant, the latter of which the Plaintiff claims has since been received by the Defendant.
4. The Defendant has acknowledged the debt and made a partial payment of CI\$4,000.00, leaving an outstanding balance of CI\$10,660.00 due and owing to the Plaintiff. A number of WhatsApp communications dating back to June 2025 are attached as well as correspondence from Counsel to the Defendant. (**Exhibit-AK1**)
5. Prior to commencing these proceedings, the Plaintiff engaged local counsel in an effort to resolve this matter without recourse to litigation. However, those efforts have proven unsuccessful due to the Defendant's failure to respond and repeated non-fulfillment of assurances to repay the outstanding sum. The Plaintiff has therefore been left with no

alternative but to seek enforcement through this Court, as further engagement of local counsel has become uneconomical. Attached are email correspondence, letter from my legal counsel, emails, and WhatsApp messages. In addition, the Plaintiff also holds a WhatsApp voice note where the Defendant confirms his commitment of repayment.

6. Below is a breakdown of the funds loaned by the Plaintiff to the Defendant:

7. The Defendant has failed to satisfy full repayment of the borrowed funds as agreed between the parties, which has caused significant distress to the Plaintiff.
8. The Plaintiff seeks simple interest of KYD\$131,790 from 02 December 2025, the date in which last payment was received and legal counsel further secured, and 11<sup>th</sup> June 2026, the date of the filing of this Plaintiff. Daily interest accrues at a rate of KYD\$0.69.

*Rules (2021 Revision)* calculated from **DECEMBER 2, 2026**  
when the cause of action arose/when the principal was demanded to the day the Plaintiff was filed ;
  3. Per diem of \$ 0.69  
from the date the Plaintiff was filed to the date judgment is entered ;
  4. Post-judgment interest from the date judgment is given until the date the judgment debt is paid  
in full ;
  5. Filing Fee \$ 25.00 ;
  6. Fixed Cost \$ 500.00 ;
  7. Bailiff Fees \$ 60.00 ;
