ORDER

UPON READING the Originating Application dated 14 August 2026 and the affidavit of Graham Robinson sworn on 14 August 2026

AND UPON READING the Applicant's Skeleton Argument

IT IS ORDERED that:

1. SPI Orange Co., Ltd. (registration number 319860) be restored to the Register of Companies maintained by the Registrar of Companies upon:-
 - a. Paying to the Registrar of Companies the sum of CI\$9,041.70 in respect of the reinstatement fee, outstanding annual return fees, and penalties; and
 - b. filing this Order with the Registrar of Companies together with the required notice that SPI Orange Co., Ltd.'s registered office shall henceforth be at 373 Ltd. (T/A "BOOKERS"), of 4th Floor, Monaco Towers, 54 Edward Street, P.O. Box 1373, Grand Cayman KY1-1108, Cayman Islands.
2. SPI Orange Co., Ltd. shall be deemed to have continued in existence as if its name had not been struck off the Register, in accordance with section 159(4)(a) of the *Companies Act (2026 Revision)*.

Pursuant to section 159(4)(b) of the *Companies Act (2026 Revision)*, any property vested in or belonging to SPI Orange Co., Ltd. which vested in the Minister charged with responsibility for Finance under section 162 of the *Companies Act (2026 Revision)* upon SPI Orange Co., Ltd. being struck off shall, upon restoration of SPI Orange Co., Ltd. to the Register pursuant to this Order, revert in SPI Orange Co., Ltd. as if it had not been struck off.
4. Notice of this Order shall be published in the Cayman Islands Gazette.
