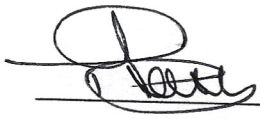

- 1 On June 2 2026, the Defendant borrowed \$4,754.00.00 and agreed to pay back the full amount plus 0% of the amount borrowed by June 30 , 2026, of a total of \$4,705.00 (Exhibit 1)
- 2 A contract was signed between the Plaintiff and the defendant fully explaining the terms and conditions including the late fees and legal action. to which the defendant stated that she fully understood.
- 3 On June 30 2026 the plaintiff sent a message to the defendant asking about the payment, the defendant replied that she will make a payment once the courts send her maintenance as it has not went to the account as yet, The plaintiff replied that that was not the arrangement you payment is to come out of your salary, The plaintiff reminded the defendant that if the payment is not made according to the contract the loan will be recalled.
- 4 As of Thursday 16 July 2026 , the defendant has not made any payment nor has contacted the plaintiff.
- 5 As of Thursday July 16 2026, the Defendant has an outstanding balance of \$\$4,705.00.00. and as per contract. \$50.00 late fee for the first day late, 20% to be added to the balance (as per contract if 5 days late) total \$5,706.00. As per contract 50% to be added to the balance (if the loan is 10 days late \$8,559.00 and simple interest at 2.38% for \$0.56 per day.

AND the Plaintiff claims:

- (1) The sum of \$8,559.00.
- (2) Fixed costs of \$150.00, \$25.00 filing fee and process server fee \$125.00 alternatively costs to be assessed.
- (3) Interest at \$0.59 per day
